An incomplete prime mover could only be entered on the RAV if this was permitted as part of the approval, such as for the fitting of lamps, reflectors or wheel guards.
		If the vehicle is intended to be a prime mover but does not have a fifth wheel assembly at the time it is entered on the RAV, the vehicle would be considered a chassis-cab and should be entered with the CC code.

States and territories are responsible for determining whether a non-RAV entry vehicle is able to operate on the roads in their jurisdiction, and any conditions on that operation. The explanatory statement for new ADRs provides information on what the standard is for and how it works. In <i>RVS News Update - Edition 32</i> we advised industry that more information is being added to explanatory statements to provide clarity and transparency around the policy intent for ADRs, to help manufacturers better interpret the technical requirements.
