#### Local Government election update

Congratulations to all the successful candidates in the local government elections held on Saturday, 21 October 2023. It is pleasing to see an increase in the number of residents who nominated for Council on Christmas Island (CI) and the Cocos (Keeling) Islands (CKI).

I look forward to working with the CI Shire President Gordon Thomson, and new Deputy Azmi Yon, and CKI Shire President Aindil Minkom and new Deputy Mohammad Isa Minkom who were all elected at Special Council Meetings held following the elections.

On CI, Kelvin Kok Bin Lee and Azmi Yon were re-elected, and Swee (Mel) Tung and Steven Pereira are new to the Council. All their terms expire on 16 October 2027.

On CKI, Signa Knight was re-elected for a two-year term expiring 18 October 2025. New Councillors Mohammad Isa Minkom, Azah Badlu and Osman Sloan were sworn in for a four-year term expiring 16 October 2027.

I personally found my time on the Christmas Island Shire Council very rewarding. I encourage all residents to be actively involved in Council activities, and take the opportunity to attend a council meeting.

# New vessel and vehicles to support community safety and wellbeing in the IOT

Construction of a new marine rescue vessel for Christmas Island is well underway, with the hull and main structure completed and works soon to move on to painting and fit-out. Once completed the vessel will undergo sea trials in Queensland before being shipped to the IOT to complete a schedule of training and commissioning.





The new vessel is slightly larger than the existing Rescue 1 vessel and will bring modern capabilities including latest generation instrumentation to support operations. Associated with the new vessel is the purchase of a new telehandler for launching and retrieval of the vessel from either Flying Fish Cove or the Ethel Beach boat ramp.

New patient transport vehicles are also undergoing fit-out ready for delivery to the Cocos (Keeling) Islands. A vehicle will be based on each island and will be used to transport those in need to/from the clinics or to a waiting medivac. These vehicles are receiving a custom fit-out to suit the specific needs of the health services on CKI and will provide safe, modern transportation for those in need on the islands.











Members of the <u>Northern Australia Infrastructure Facility (NAIF)</u> team had the privilege of visiting the Cocos (Keeling) Islands during October. As part of the Indian Ocean Territories, the Islands are included within the NAIF's northern Australian boundaries following legislative changes earlier this year.

The visit to Cocos Keeling Islands follows NAIF's recent trip to Christmas Island in September.

Led by NAIF's Chief Investment Officer Stephen Land and Director Stakeholder Relations Matthew Derlagen, the NAIF team met with local organisations, businesses, and other stakeholders to discuss opportunities, particularly within the tourism sector. The key focus of NAIF financing is to drive public benefit, and economic diversification in the region.

The NAIF team would like to thank all the local organisations and business representatives who took the time to meet with them, with a special mention to Assistant Secretary Indian Ocean Territories, Kim Forbes for her warm welcome and for showing us around.

# Margaret Knoll lookout upgrade completed

The upgrades to the Margaret Knoll boardwalk and lookout have been completed, providing visitors to the national park with a modern and safe vantage point to observe the extraordinary and diverse birdlife of Christmas Island.

The Australian Government committed \$2.9 million to complete the works at the popular lookout, which included entirely replacing the viewing platform and boardwalk. The upgrades include sustainable design elements, including new visitor seating made from recycled plastic.

The upgrades were made due to structural concerns, with the government prioritising the safety and wellbeing of the residents and tourists alike who come to Margaret Knoll to view the spectacular coastline, as well as the breeding grounds for a number of endangered birds, endemic to Christmas Island, including the Christmas Island frigatebird and the rare Abbott's booby bird that call the island home.

#### **Historic Jukong Restoration Project**

It is said that a community without the knowledge of their origin, history and culture is like a tree without roots. And much like a tree, without care and nurturing, the culture of a community will not thrive.

..

In response to strong community interest, the Australian Government, Shire of Cocos (Keeling) Islands (CKI) and the Western Australian Museum – with the valued support of the Australian National Maritime Museum – have initiated a project to restore the five remaining historic jukongs on Home Island. Collectively, they represent the evolution of Jukong design since the early 1900s.

The project is part of a broader program which aims to preserve and record traditional Cocos Malay cultural heritage. But it is the intangible heritage, that 'handed down' knowledge which is most at risk of being lost. Home Islanders have been well known for their superior boat building skills for more than a century.

In recounting his solo voyage around the world, master mariner, Joshua Slocum recalls of his visit to the atoll in 1897.

".... The men of Keeling build exquisitely modelled canoes. By far the best workmanship in boatbuilding I saw on the voyage was here."

Much of the traditional boat building knowledge and skills is now held by just a few. Men such as Nek Callum, Nek Su and Parsons bin Yapat.

This project aims to tap into the vast experience of these master boat builders to bring these old and deteriorating boats back to life while at the same time transferring their knowledge and skills to a younger generation of enthusiasts to safeguard the continuity of this important custom.

The project is anticipated to run for the next 2-3 years. During this time, it is hoped that keen interest in learning the skills and techniques of traditional boat craftsmanship will bring in the volunteers that are needed to make this project truly successful. All are welcome.

And as always, this leads to another story of Home Island families, for each boat has a corresponding family history attached to it. It's a self-evident truth on the Island, families are the glue that have held the community together.

The first milestone is to stabilise the condition of each jukong. The Chula Shed will be repurposed as the restoration workshop and ultimately, the display area for the collection. The 'Chula' will remain in situ since it and the jukongs are lead characters in the story of the copra industry on island. The community and visitors are welcome to visit as these are handed down to the following generations.

And did you know we have models too? We have discovered a small collection of halfboat models from the early 1900s that were recorded as missing. All are in urgent need of very careful restoration and conservation. This work has already started and some will need serious resurrection but once completed we will be 3D scanning these models for a permanent record.



Ini Logi c. 1950s. Adapting to lean times this was one of only four boats to be built with steam bending methods, that used minimal material and was the last known boat to be made entirely from the old stocks of teak.

Ini Lagi now, as it is cleaned and made ready for relocating into the Chula Shed and the commencement of the restoration works.



The Chula Shed is now 'almost' empty and clean. Soon it will be converted to a workshop where Seniors will now be able to put their old skills back into use and begin the detailed work of restoring the old jukongs.

We sang familiar songs, played instruments, engaged in gentle movements and enjoyed morning tea together. This was such a wonderful form of community engagement and there were smiles all around.



# CHRISTMAS ISLAND PORT - REPORT ON INFRASTRUCTURE - WHARF CRANE UPDATE

Stage one of the remedial works to the wharf crane have commenced. Local contractors have been engaged to carry out the recommended actions of the structural engineer's report and address the findings of the non-destructive test reports. The recommendations from the crane's manufacturer, Favelle Favco Cranes Australia (FFCA), are still being finalised and the agreed requirements will be packaged into stage two of the works.

On the current schedule, it is anticipated the crane will be entered back into service in January 2024. The logistics involved in a project of this nature are complex; and the Island's geographical location and isolation does not lend itself to a faster timeline. It is important to note that the crane will require independent certification before it comes back into service. Notwithstanding this, all best endeavours are being employed to advance the recommissioning of the crane as far as practicable.

In the interim, general cargo operations will continue to be conducted by the port barges over the water to the gantry crane on the FFC jetty.

Our obligation to provide a safe work environment for maritime industry participants is paramount and we are progressing this process as a priority. We assure you of our best intentions at all times.


