To whom it may concern,

## Article 19 from the UN's Universal Declaration of Human Rights:

"<u>Everyone</u> has the right to freedom of opinion and expression; this right includes freedom to hold opinions <u>without interference</u> and to seek, receive and impart information and ideas through any media and regardless of frontiers."

Australians will not have the right to freedom of online opinion and expression as expressed by the UN Universal Declaration of Human Rights if this Orwellian Bill becomes law.

If you want to know who rules over you, simply find out who you are not allowed to criticise. Is that the Australia we all want to live in?

If freedom of opinion means anything at all, it means the right to tell people online what they do not want to hear.

Thomas Jefferson, 3rd US President, was right when he said that "The liberty of speaking and writing guards our other liberties."

And who in ACMA decides what constitutes misinformation and disinformation?

Take for example during the early days of the Covid-19 pandemic when the mere suggestion the virus came from an accident from the Wuhan laboratory was labelled as misinformation and disinformation. Social media platforms at the behest of Govts everywhere silenced such talk on social media. Fast forward to now and it is widely acknowledged that there could have well been a laboratory leak and it's actually ok to talk about it now but not 3 years ago.

Another example a few years back was the amount of people coming forward online to share their unfortunate personal experiences with the two mRNA vaccines. So give me the continued right to free speech, whether it be me standing on my soap box in the real public square or in the online public square and I'll use it to secure and protect all of my other human rights.
