

# Submission to the ACMA laws commission

I am making this submission to give my opinion on the proposed Australian Communications and Media Authority legislation (ACMA).

I do not in any way approve of this legislation.

This legislation sounds very much like a tyrannical, dictatorial set of rules and regulations that will destroy the very concept of freedom of speech that Australian democracy is based upon. It is designed to promote only one side of every argument - the side of big Government, big Media and big Pharma. That is not democracy.

The fact that the Australian government and the mainstream media are mostly exempt from this legislation is a massive red flag that these laws are not meant to stop misinformation and disinformation but to merely shut down any opinion that isn't sanctioned by the government and the media (not to mention the WHO, the CDC and [REDACTED]).

Moreover, the last institutions that can claim they are always correct and never tell untruths would be the Australian government, the mainstream media and Big Pharma ([REDACTED]).

During the Covid-19 pandemic the Australian government and the media were completely wrong regarding most aspects of the virus, the disease, the lock downs, the face masks and the Covid "vaccines".
