## Communications Legislation Amendment (Combatting Misinformation and Disinformation) Bill 2023

Please allow me to preface this submission with the foundation of a Biblical perspective. Jesus states in John 14:6, "Jesus saith unto him, I am the way, the truth, and the life: no man cometh unto the Father, but by me."

This means that Jesus is not only the arbiter of truth, He is truth itself.

Firstly, I would like to address the point included in the Communications Legislation Amendment Bill that "misinformation and disinformation pose a threat to the safety and wellbeing of Australians, as well as our democracy, society, and economy." Can I respectfully suggest that state-imposed (subjective) truth poses a threat to the safety and wellbeing of Australians, as well as our democracy, society and economy. Australia's democracy and society has been built on the principles found in the Bible, which is the source of objective truth (see Jesus's statement earlier in the book of John).

Secondly, the proposed Bill stands in directly Opposition to both Australian and international human rights. For example, this statement from the Australian Human Rights Commission- "There is a real risk that efforts to combat online misinformation and disinformation by foreign-actors could be used to legitimise attempts to restrict public debate, censor unpopular opinions and enforce ideological conformity in Australia." Lastly, the terms defined in the Bill are much too broad, vague and general in nature to be beneficial, and instead could very easily be manipulated by those with ulterior motives. For example, misinformation is defined in the Bill as "content disseminated using a digital service that is false, misleading or deceptive..." The threat is described as aimed at "...our democracy, society and economy." These terms are extremely wide-ranging and ambiguous in nature, making it easy prey for those who wish to exercise excessive power or control over the Australian people.
