SUBMISSION RE: The Communications Legislation Amendment (Combatting Misinformation and Disinformation) Bill 2023.

To Information Integrity Committee,

I write this submission to express my concerns over such an act "combatting Misinformation & Disinformation"

1.a. MP's & Senators take an Oath or Affirmation before God & before Australian Citizens & to hold them accountable to the Citizens of Australia who they are to serve

OATH: "I, A.B., do swear that I will be faithful and bear true allegiance to Her Majesty Queen Victoria, Her heirs and successors according to law. So Help Me God!

AFFIRMATION: "I, A.B., do solemnly and sincerely affirm and declare that I will be faithful and bear true allegiance to Her Majesty Queen Victoria, Her heirs and successors according to law"

- 1.b. Our Sovereign who MP's have sworn public allegiance to is by Coronation Oath "Defender Of the Faith" = Judeo Christian Faith.
- 1.c. The Law on which our Constitution is founded on gives all citizens the RIGHT of FREEDOM of SPEECH & Freedom of conscience & opinion.
- 1.d. The Universal Declaration on Human Rights of which Australia is a signatory & which is legally binding. The UDHR recognizes the rights enshrined in the UDHR (1948) as basic human rights for all peoples of the world & it clearly states:

PREAMBLE UDHR (1948) "Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world,

Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,"

Article 3 "Everyone has the right to life, liberty and security of person."

Article 7 "All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this Declaration and against any incitement to such discrimination."

Article 12 "No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks."

Article 18 "Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance."

Article 19 "Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers."

2. The job of MP's & Senators by Oath of Office is to DEFEND our Constitutional Right to FREE SPEECH - Australian men

& women died in two World Wars & other wars, defending our FREEDOM of SPEECH FREEDOM to live in safety in our land.

- 3. The very terms "Misinformation" and "Disinformation" are so politicized & misused to cancel opinions of those who have genuine well founded knowlege & understanding on various social issues!

The UDHR (1948) clearly states:

Article 16:

- 2. Marriage shall be entered into only with the free and full consent of the intending spouses.
- 3. The family is the natural and fundamental group unit of society and is entitled to protection by society and the State"

Article 25:

- 1. Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.
- 2. Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection."
- e.g. Climate Change any genuine concerns regarding the Climate Change Narrative are labelled "Misinformation / Disinformation" NASA came out publicly stating last year that Climate Change is not man made but due to the Sun, will that be labelled "Misinformation / Disinformation"???
- e.g. There is now a huge amount of Medical & Scientific Data showing the links between excess deaths & vaccine injuries since the Covid mRNA vaccine roll out will that be labelled "Misinformation / Disinformation"???
- 4.
