Assessment timeframes quarterly report

This report provides statistics on the average time taken to assess applications made under the Road Vehicle Standards (RVS) legislation.

This is the first edition of a quarterly report that provides statistics captured in ROVER¹ on assessment timeframes for applications. This report covers applications decided between 1 January 2024 and 31 March 2024. Statistics in future reports will include cumulative figures, up to a 12-month period. See Explanatory notes for further details.

Highlights

- There were 11,245 applications decided in this reporting period.
- The top 3 application types (by volume) decided were concessional RAV entry approvals (8,917), followed by vehicle type approvals (938) and advisory notices (412).
- Applications for component type approvals have taken the most time to decide, with new applications taking an average of 34.1 processing days and variation applications taking 32.2 days on average.
- Of all new applications decided in this reporting period, only 4.8% were submitted more than once before a final decision was made.
- All decided new applications for authorised vehicle verifiers were submitted once only. Conversely, 49% of all decided new Model Report applications were withdrawn and resubmitted.

Explanatory notes

This report includes data on decided applications (new, varied and resubmitted) for the period 1 January to 31 March 2024.

The types of decisions made include granting an approval, refusing to grant an approval or refusing to consider an application.

Data on any application still under assessment have not been included in this report.

A new application is an application that has been submitted for the first time. A variation application is when an approval holder applies to make a change to an existing approval.

An assessment day is counted as a business day in the Australian Capital Territory².

The processing time starts the day after the date the application is submitted and paid. However, if an application was submitted, assessed and decided on the same day, it is counted as one processing day.

The assessment clock pauses when the department makes a RFI and then resumes when the applicant responds to the RFI.

The legislated timeframe for processing vehicle type approval, component type approval and Model Report approval applications is 60 business days. All other application types are 30 business days, including advisory notices which are subject to a service charter timeframe of 30 business days.

¹ ROVER is the department's IT system that supports the administration of the RVS legislation and is the only system that can be used to submit applications.

² A business day under section 5 of the <u>Road Vehicle Standard Rules 2019</u> means a day that is not a Saturday, Sunday or public holiday in the Australian Capital Territory.
