Lexus Australia (Lexus) thanks the Department of Infrastructure, Transport, Regional Development, Communications and the Arts (DITRDCA) for the opportunity to respond to the 'Fuel Efficiency Standard – Cleaner and Cheaper-to-run Cars for Australia' consultation paper (FES).

Lexus is a luxury-focused brand that has been in the Australian market since 1990 with a national network comprising 22 dealers across 29 sites delivering a range of premium light vehicles.

We are committed to the goal of 100% electrification by 2030 with our vehicle line up comprising hybrid (HEV), plug-in hybrid (PHEV) and battery electric (BEV) and by 2035, Lexus globally is seeking to shift to 100% zero emissions vehicles (ZEV).

Overall, Lexus supports the introduction of a national Fuel Efficiency Standard for light vehicles which sets challenging but achievable targets working towards the primary goal of emissions reduction.

Lexus is a member of the Federal Chamber of Automotive Industries (FCAI), and broadly endorses their submission to the 'Fuel Efficiency Standard – Cleaner and Cheaper-to-run Cars for Australia' consultation paper (FES).

International benchmarks show that a holistic package of arrangements are needed including: targets, support towards infrastructure, consumer incentives, credits, and other complimentary policy measures. Without this holistic approach there is a risk of driving vehicle prices up and/or restricting or eliminating availability of some makes and models.

The Australian market is multi-faceted and requires a considered approach to implementing a FES and the FCAI current industry code provides a logical baseline.

Key points

- Principles: Lexus agrees with the principles set out in the Consultation Paper.
- Targets: Targets need to be established and be appropriate to the Australian context. A target number is really only one element of a broader package of arrangements that need to be viewed holistically.
- Timeframe: Lexus believes that a cautious start finish strong is the appropriate approach, incorporating a long-term visionary target (10 years) with built-in periodical reviews every 3 years.
- Penalties: Lexus acknowledges that penalties are logical in the context of a mandated scheme as they send a signal to suppliers but should be considered as a last resort.
- Credits & Multipliers: Lexus sees these as being an important function of a robust FES scheme. Super credits, off-cycle credits, air conditioning refrigerant gas credits, etc. are important mechanisms to encourage supply to market.

The industry voluntary scheme, as managed by S&P Global, provides a readily available and robust source of data and reporting tool suitable for a mandated Australian FES.

In conclusion, Lexus welcomes the policy certainty that an Australian FES will deliver, and we look forward to continuing to work with government.
