



This brief provides information on the decision for the appointed artistic team for the 2026 Venice Biennale. 2026 will be the 26<sup>th</sup> edition of Australia's participation at the Venice Biennale which commenced in 1954.

Creative Australia is the commissioner of the Australia Pavilion and the producer of the Australia at the Venice Biennale project, which incorporates the exhibition within the Pavilion, a suite of professional development programs for Australian creative and cultural workers, and a co-investment program that garners support and advocacy for the project.

**Khaled Sabsabi** has been appointed as the 43<sup>rd</sup> artist to present in the Australia Pavilion in the category of National Participation. **Michael Dagostino** has been appointed as the curator for the artistic team. Both members of the artistic team are from New South Wales.

As set out in our brief sent on Monday 20 January 2025, Creative Australia will publicly announce the 2026 Venice Biennale Artistic Team on **7 February 2025**. We invite you to include a quote in the media release, a draft of which is attached (**Attachment 1**).

### Background

1. Creative Australia is the commissioner of the Australia Pavilion and the producer of the Australia at the Venice Biennale project, which incorporates the exhibition within the Pavilion, a suite of professional development programs for Australian creative and cultural workers, and a co-investment program that garners support and advocacy for the project.

### **Assessment Process**

- 2. Stage one expression of interest applications opened on 27 August 2024 and closed on 8 October 2024.
- Creative Australia convened a panel of five industry advisors. The industry advice panel was
  carefully appointed from a longlist that was Board approved. 51 eligible applications were
  submitted to the stage one expression of interest.

Michael Dagostino was the founding director of Parramatta Artists' Studios, later Director of Campbelltown Arts Centre, and currently Director of the Chau Chak Wing Museum at the University of Sydney. Dagostino has embedded an intentional artist-driven approach to all of his curatorial and director roles, facilitating access, equity and authorship.

Reflecting on his collaboration with appointed curator Michael Dagostino, Khaled Sabsabi said:

ANDREW BOLT: I want to show you something that is, to me, just so amazing. I mean, says so much. We heard - I really played some of Albanese's - Anthony Albanese's response today, really flat, like he didn't have his heard in it. I think one of the problems here, Rowan, is as you've pointed out many times, the government comes into this with dirty hands, right?
