Welcome Message

Welcome to the first edition of my newsletter for 2025.

I hope you had a restful holiday season, and are now looking forward to the next twelve months and the possibilities ahead.

I would like to particularly wish all those who celebrated a happy Chinese New Year, and bid farewell to the Year of the Dragon, and welcomed in the Year of the Snake. The most tenacious of the 12 zodiac animals, the snake symbolises growth, wisdom and transformation – all vital qualities for the coming year.

Already across both Christmas and Cocos we have seen extreme weather events at our door. I have been working closely with the Emergency Management Committees, and the communities, on disaster response and preparedness, and thank everyone involved for their efforts during the worst of the swells and now through the clean-up, assessment and repair process to come.

I encourage all of you to follow the [IOT News Facebook page](#) for the latest emergency management information, including storm warnings and advice for preparing for storms and extreme weather events over this wet season.

There is no doubt that extreme weather and the impacts of a changing climate will be a key focus for 2025, with the final consultations on the Cocos (Keeling) Islands Coastal Hazard Risk Management and Adaptation Plan (the Draft CHRMAP) now under way. The CHRMAP is how we can best understand the impact of rising sea-levels on Home and West Island, and to work together to determine a way forward over the next 50 years.

Currently, the draft is open for public comment – and I urge Cocos Islanders to read and review the document, a summary of which is available in both English and Cocos Malay here:

I just returned from a visit to Cocos where I met with a number of community members and I understand that for so many, this is a time of uncertainty.

I want to assure all of you that myself, and the Australian Government are committed to supporting you throughout this process by designing a pathway forward for Cocos in partnership with the community.

Noting concerns raised about flooding on Home Island, the Department is assisting the Shire to assess options to address this. The Department has asked the WA Government to develop a Water Management Report (WMR) for Home Island to support the Shire to better understand groundwater flooding risks and management options. This work is being progressed as a priority.

While on Cocos, I also met with the new AFP officer in charge Nick Bannan and discussed a range of emergency management and community policing matters.

Looking ahead, we have a number of opportunities to build a stronger, more resilient region here in the IOT.

Round Three of the Disaster Ready Fund is now open, with \$200 million available across 2025-26 to support projects addressing the physical and social impacts of natural disasters on Australian communities. I encourage anyone interested in applying for a grant for projects supporting reduced disaster risk and building long-term resilience in the IOT to read the guidelines on the Department of Fire and Emergency Services (DFES) website.

We have already seen the impact that Australian Government investment can make on the day to day lives of our community, with the Christmas Island Daycare being awarded \$25,000 in grant funding for professional development. Once again, many thanks to

the Shire and all involved in this important grant, that will make such a difference to the early childhood sector on CI.

You can read about these stories and more in the newsletter, which captures only the highlights and key moments of the past month. Latest News

Cocos Islanders invited to have their say on CHRMAP draft

Community consultations on the final draft of the *Cocos (Keeling) Islands Coastal Hazard Risk Management and Adaptation Plan* (the Draft CHRMAP) are under way, with Cocos Islanders encouraged to have their say on this important document.

The Australian Government engaged the Western Australian Government to develop the CHRMAP for Cocos, as a means of understanding the impact of

rising sea-levels on the coastlines of Home and West Island, and to outline a potential pathway forward over the next 50 years.

After previous workshops regarding options in 2022 and 2023, this current round of consultations is the final stage of the vital project, with community, industry and local government feedback an important part of its finalisation.

The draft CHRMAP is now available for public comment, with the community encouraged to share their thoughts on the plan.

The project team engaged to deliver the consultations, Shape Urban, was on island in late January – supported by the Australian and Western Australian governments – undertaking initial discussions with the Shire and community representatives about the draft report

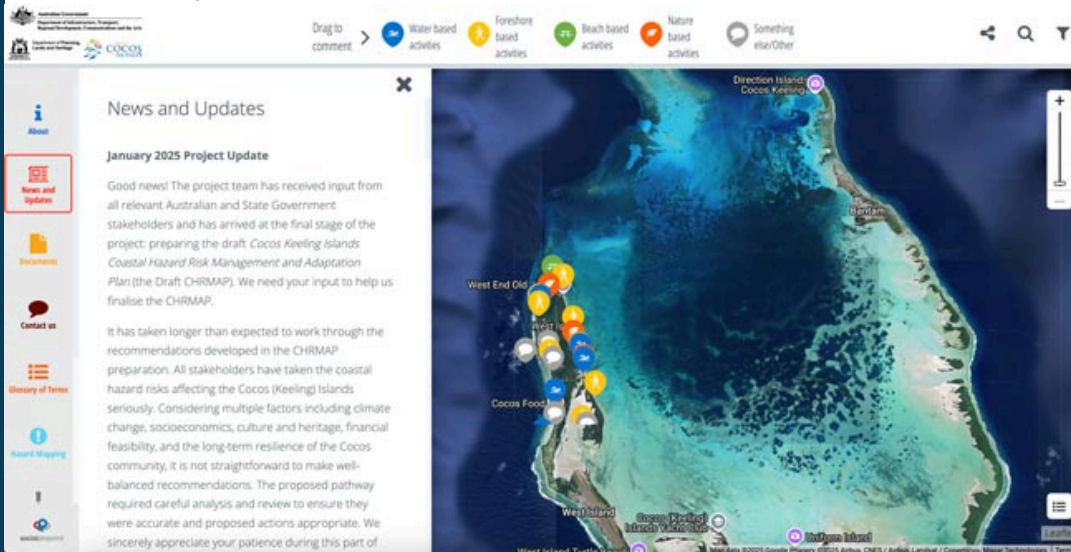
Shape Urban will return in April for further discussions with the community about the proposed recommendations, providing the opportunity for stakeholders to ask more detailed questions on the proposals outlined in the report.

Dates and details for these information sessions will be released shortly.

The draft CHRMAP is an important part of the Australian Government's response to the impacts of climate change on Cocos, which includes a \$23.3 million investment in improving emergency preparedness and community safety while the long-term response is developed, which was announced late last year.

Exciting boost for early childhood education on Christmas Island





In fantastic news for children, parents, carers and early childcare workers on Christmas Island, Christmas Island Daycare staff are set to receive \$25,000 as a development and incentives package thanks to the Western Australian Government.

The Commonwealth-funded grant was secured under the West Australian Grant Attraction and Retention Packages for Regional Child Care Workers Program, which provides grants to local governments across regional Western Australia to fund initiatives supporting early childhood education and the care workforce.

The \$25,000 in grant funding, applied for by the Shire of Christmas Island, will go towards the professional development of Christmas Island Daycare staff,

ensuring they are well supported in their vital roles of helping educate and care for our children during such an important phase of a child's life.

Early childcare workers have one of the most important and challenging roles in a child's development, with high quality early childhood education and care providing important opportunities for learning and socialisation which is why investing in a highly skilled, well-supported workforce is one of the most important ways we can give children the best start in life.

Many thanks to everyone involved in the grant application, and to the West Australian Government for working with them to access this scheme.

Kampong Waste Water Pipeline Replacement Project Update

The replacement of the wastewater pipeline in Christmas Island's Kampong is progressing, with works expected to commence on site later this month with an anticipated completion date of late April this year.

This important project will see the realignment of the wastewater pressure main, and a new alignment along Jalan Pantai, which will not only improve inground infrastructure to reduce maintenance costs, but will also improve safety for Water Corp's employees and contractors undertaking repairs near rockfall zones.

Water Corp is delivering this project on behalf of the Australian Government, with Saltire Infrastructure – a

specialist company experienced in delivering water infrastructure.

There will be some impact to road access during the project which will be minimised whenever possible.

There will also be some minimal impact to the Flying Fish Cove carpark area, however it will remain open through the works period.

Protecting our extraordinary marine parks



The Australian Government has released the first ever management plans for the Indian Ocean Territories Marine Parks, supporting better, long-term protection for our extraordinary and diverse marine ecosystem.

The plans focus on:

- protecting, researching and monitoring park biodiversity and habitats, including enhancing climate change resilience and adaptation;
- community stewardship, including supporting and recognising the traditional practices of island communities;
- continuing to work closely with other government agencies and other stakeholders with mutual and related interests;
- management rules aimed at protecting park values, while simplifying administrative processes for local communities and other park users.

Thank you to everyone who made a submission to these important plans – your local knowledge and experience of the parks has helped inform how they will be managed and protected for future generations.

More than 20,000 public submissions were received during the preparation of the plans, clearly demonstrating the global significance of our beautiful region.

Thank you also to the Parks Australia staff who have worked so diligently to make sure that these plans will protect our unique marine environments for decades to come, while recognising and respecting the strong connections our communities have to these waters.

Subsidised Travel Reminder for IOT Pensioners and Students

Eligible students and pensioners across Cocos and Christmas Islands are reminded to take advantage of the Student Subsidised Travel Scheme and Pensioner Annual Free Trip Scheme offered by the Australian Government – supporting IOT residents who meet scheme requirements to get to and from the mainland.

Under these schemes, pensioners who have a Pensioner Concession Card issued by Centrelink and who have been living continuously in the IOT for two years or longer are entitled to receive one free return airfare to Perth per calendar year, while secondary and tertiary students not already receiving any type of Centrelink Youth Allowance can receive assistance to travel to attend their full-time studies.

Thanks to these Australian Government schemes, eligible IOT residents are receiving assistance comparable to other remote WA communities. The scheme guidelines can be obtained from <https://www.infrastructure.gov.au/territories-regions-cities/territories/indian-ocean-territories/travel-schemes>

Round Three of Disaster Ready Fund Open for Applications

The Australian Government's Disaster Ready Fund (DRF) is delivering \$200 million of Commonwealth funding annually to establish disaster resilience and mitigation projects across Australia.

Applications are now open for Round Three of the DRF to support projects addressing the physical and social impacts of natural disasters on Australian communities.

The Government is supporting the Indian Ocean Territories in the face of extreme weather events and natural disasters through Christmas and Cocos Islands' inclusion in the DRF.

The WA Department of Fire and Emergency Services (DFES) is the Lead Agency for DRF applications from the IOT. The National Emergency Management Agency (NEMA) introduced changes for Round Three, which are summarised on the DFES website.

To apply for Round Three of this important program, you must review the Round Three Guidelines before applying, and read the supporting resources on the DFES website to prepare the strongest possible application. The attached factsheet summarises the process for IOT applicants, but should not be read in place of the Guidelines.

Project proposals must be submitted by 5pm (AWST) on 2 April 2025 via the DFES online application portal: <https://dfes.smartygrants.com.au/DRF2526>.

DRF is administered by the National Emergency Management Agency (NEMA) on behalf of the Australian Government.

The Secret Life of the CI Paper Wasp!

The Indian Ocean Territories have a vast and varied array of wildlife, including the smaller and sometimes overlooked insects of the IOT. Dr Anna Probert from the University of New England visited Christmas Island this month to conduct research into the endemic CI paper wasp. During her visit, I met with Dr Probert to discuss the work she is doing, as well as the impact the invasive Macao paper wasp is having on the Cocos (Keeling) Islands.

Dr Probert is keen to establish a citizen science surveillance project on Christmas Island to prevent the Macao paper wasp making its way to CI from Cocos. Christmas Island residents are encouraged to learn the differences between the native and Macao paper wasps, so that spotting the invasive species becomes easier.

If you see a wasp that you think looks like a Macao paper wasp, please take a photo if possible and make a note of the location of the sighting. You can then send the details to cipaperwasp@une.edu.au or also use this email address if you'd like further information on wasps in the IOT.

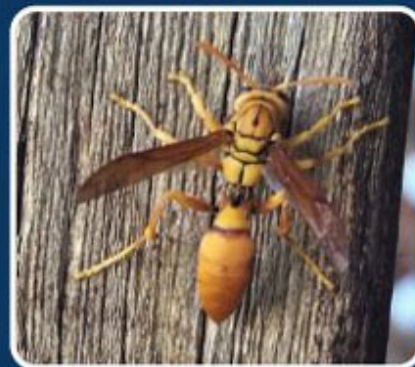

Macao paper wasp:

- is an exotic pest wasp and is established on the Cocos-Keeling Islands
- is larger than the Christmas Island native paper wasp, *Polistes balder*
- has wavy black bands on the abdomen, as seen above (top left)
- has larger nests, often with hundreds of wasps in the colony
- could hitch-hike to Christmas Island via freight and boat movements

The Indian Ocean Territories Administration (IOTA) is currently seeking motivated, professional and suitably qualified persons to join our team as an HV/LV Electrical Supervisor within the Indian Ocean Territories Power Service (IOTPS) based on Christmas Island.

The IOTPS is the recognised Network Operator for the Indian Ocean Territories and is responsible for the generation and distribution of a safe, reliable and efficient electricity supply to residential, commercial and industrial consumers on Christmas and Cocos (Keeling) Islands. IOTPS also provides regulatory

compliance in collaboration with the Department of Energy, Mines, Industry Regulation and Safety.

The key responsibilities of the HV/LV Electrical Supervisor are to plan and schedule the IOTPS electricity distribution network and power generation electrical maintenance activities and to supervise and manage all electrical, instrumentation and control system works performed by the maintenance team and maintenance contractors.

To be considered, applicants must possess a current and valid Western Australian Unrestricted Electrical Worker's Licence (Applicants with Interstate Electrical Licences which are eligible for mutual recognition in WA are welcome to apply. However applicants must hold an unrestricted Electrical Worker's Licence (WA) at time of commencement), must be listed as a nominee on IOTPS' in-house installation work licence within 6 months of commencement, hold a current manual 'C' class, or higher, driver's licence transferable to the Indian Ocean Territories and will be subject to a health assessment.

Our ideal candidate will have substantial post qualification trades experience with strong leadership and people management within the power or construction sector, extensive knowledge and experience of the power industry, demonstrated experience with power generation equipment (preferably medium speed diesel engines and HV alternators) and a demonstrated ability to motivate teams with professionalism, fairness, resilience and flexibility while demonstrating accountability for outcomes and behaviours.

The Power Services Manager is primarily responsible for managing the delivery of safe, reliable and efficient power generation, distribution, billing and electrical inspection services for the Indian Ocean Territories (IOT's), delivering continuous improvement in safety, risk management, asset reliability and resilience and undertaking project and contract management relating to the provision of power services.

This is a critical operational management position and pivotal to success is leading and developing a high performance team within a multi-cultural workplace and fostering a values aligned culture. The role also plays a key role within the Senior Executive Leadership Team of the IOTA.
