Earlier this month Adam made the trip over from Canberra to Christmas and Cocos Islands, and was able to meet with stakeholders and tour infrastructure and projects over the week. These face-to-face visits are vital to supporting community-led projects and policies – ensuring greater community engagement and input.

With January having flown past, we are looking ahead across the next few months, with a particular focus on some key announcements and projects around the future sustainability of our region.

Progress has been made on a Coastal Hazard Risk Management and Adaptation Plan for Cocos, with a final report expected to be delivered mid-year – you can read more on this in the newsletter – while the Australian Government is also supporting our future preparedness through expanding eligibility for the Disaster Ready Fund, with applications now open.

As a region vulnerable to natural hazards, we want to be as prepared as possible for future natural disasters, and I urge all of you to make sure you are ready in the event of a cyclone, coastal inundation or landslide. Make sure you are reviewing your storm preparedness safety plans, know where to go in the case of evacuation and know who to call in an emergency.

New Christmas Island Marine Rescue boat hits the water for the first time



The new Marine Rescue boat for Christmas Island was successfully launched earlier this month and is now set for final inspections before heading out to sea to undergo a more comprehensive round of testing and trials.

Once the boat has passed its trials, it will be shipped to the IOT where, after a schedule of training and commissioning, it will become an invaluable addition to Christmas Island's marine rescue capabilities.

Larger than the existing rescue vessel, the new boat has the most up-to-date instruments and equipment installed to support operations around Christmas Island.

The "Best Australian Beaches" list is out for 2024 and this year Pulu Blan Madar has come in at number 5.

Tourism Australia's Beach Ambassador Brad Farmer AM, was the adjudicator of the annual top 10 list of beaches, which were chosen from the almost 12,000 contenders found across the mainland and external territories.

While Squeaky Beach in Victoria took out the number one spot, Mr Farmer noted the "mirage like magical appearance of rustling coconut palms seemingly floating on its flour-soft sand," that makes Cocos one of the most beautiful locations in Australia, and the world.

Pulu Blan Madar is one of the Cocos (Keeling) Island's natural wonders, and we are thrilled to see it recognised in this year's list of best beaches.

Dolly Beach on Christmas Island also received an honourable mention, showcasing the extraordinary beauty of our region.

Update on the Cocos (Keeling) Islands Coastal Hazards Risk Management and

Adaptation Plan

The Australian Government is partnering with the Western Australian Department of Planning, Lands and Heritage (DPLH) and the Shire of Cocos (Keeling) Islands (CKI) to develop a Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) for CKI.

Funded by the Australian Government, the CHRMAP will help understand how CKI's coastlines will be affected by sea-level rises, including coastal erosion and inundation, over a 100-year timeframe.

The Government has undertaken extensive community engagement on CKI, with residents providing information about how they value and use the coastline, which is helping inform options being developed to manage future coastal risks. I would like to thank everyone who participated in these sessions in 2022 and 2023, and note that there will be further community consultation in the future as we implement the next steps in the CHRMAP process.

DPLH is currently developing the CHRMAP report, which is expected to be completed in mid-2024. This is a very complex piece of work, and it is important to take the time to get it right. Once the CHRMAP is completed, it will support government and private sector decision-making, including future infrastructure planning and investments on CKI, and the management of any future hazards to keep the community and environment safe into the future.

All three tiers of government share a commitment to addressing the challenges of coastal hazards currently impacting the community. I will keep the community updated on the progress of the CHRMAP as more information becomes available.

Community updated on the Cocos runway project

The Department of Defence returned to the Cocos (Keeling) Islands early in February, to update the local community, businesses and other stakeholders on the runway project.

The project will upgrade the airfield at CKI to meet Defence's capability requirements and improve overall airfield safety for all aircraft. It will involve strengthening and widening the runway and taxiways, strengthening and reconfiguring the existing apron, refurbishment of lighting, stormwater drainage works, a 150m extension of the runway and removal of legacy Defence waste from CKI.

In a range of meetings, including three community information sessions across Home and West Islands, Defence and its lead contractor Fulton Hogan outlined the scope of the project and its stages to the community. They also provided information on employment and training opportunities and opportunities for local businesses to bid to support the project. In the community sessions, questions about impacts to the community, local economy and environmental protection were addressed.

Fulton Hogan will be sub-contracting a number of works packages throughout the project, with employment opportunities available through subcontractors.

With the finishing touches to the design being finalised in coming months, work on CKI is expected to commence in mid-2024 with the Material Offloading Facility (MOF). This will be followed by work on the construction camp in the second half of 2024. Both are anticipated to be completed early in 2025, with runway works from mid-2025 to mid to late 2027.

There will be further on-island engagement once the subcontractor for the MOF is in place, including more information on local opportunities related to that package of works.

Historic 'Z' Plates on display



In a blast from the past, a set of Commonwealth of Australia 'Z' plates were recently located by the Christmas Island Motor Vehicle Registry.

The 'C of A' black-on-white background plates with a red 'Z' prefix were introduced in 1951-1952 for use by Commonwealth Government departments throughout Australia, so they could be distinguished from state and territory plates.

In 2000, the Commonwealth Vehicle Registry closed, and each state and territory became responsible for the issue of Australian Government number plates.

Each state and territory replaced 'C of A' with their state initials, except for the Northern Territory who still uses 'C of A'.

With approval from the Department of Infrastructure, Transport, Regional Development, Communications and the Arts, the plates are now on display in two locations.

One plate can be viewed on Christmas Island at the museum in Tai Jin House here on Christmas Island, the other is on display at the Motor Museum of Western Australia.
