Independent review of Infrastructure Australia

I am pleased to provide some comments to the review of Infrastructure Australia on behalf of the National Transport Commission (NTC).

The NTC is a statutory body that leads strategic national land transport reform to improve safety, productivity and environmental outcomes. It is accountable to Australian Transport Ministers through the Infrastructure and Transport Ministers' Meeting (ITMM) – the only national transport body to have this function.

The NTC and Infrastructure Australia have a proud history of effective collaboration to advance strategic reforms at the national level. In particular, the NTC has assisted Infrastructure Australia as it undertakes the following functions:

- Leads and informs the debate on infrastructure policy and reform by supporting
 jurisdictions with seamless implementation and developing harmonised policy and
 regulatory frameworks. The NTC can provide the transport policy context for the
 consideration of infrastructure policy and to assist governments align these
 reforms.
- Monitors the market's capacity to effectively deliver infrastructure projects by progressing the skills harmonisation and transferability in the rail sector as part of the National Rail Action Plan and establishment of the Women in Transport Initiative which aims to increase the participation of women in the transport industry.

In fact, Infrastructure Australia's 2021 Australian Infrastructure Priority Plan identifies several focus areas for the NTC to progress.

In addition, during Covid the NTC and Infrastructure Australia agreed to co-locate staff from each organisation in each other's respective offices in Sydney and Melbourne. This cooperation also enhanced coordination and collaborative national policy and reform development.
