I believe we do not need an E-Safety commission to decide for us what we view online. Who decides a footage is deemed inappropriate. If I do not want to a footage, I shall turn it off.

We all saw September 11 attacks on TV, we saw photos that were very confronting. We see images of war and terrorist attacks around the world every day. Where do you draw the line. We saw the Bondi junction knife attack footage a week earlier.

And the images and scenes of the Wakeley stabbing 15th April 2024, were sad to see that is happening in Australia. But it is reality. Terrorism was always something that happened overseas until the Lindt Cafe Siege. However, the answer is not to censor the images to protect the public but how to solve the problem. To address the root of the problem should be the main aim but not to censor what the public sees on line. If it is a mental health issue, we address mental health, if it is a religious ideology issue we address and confront the ideology.

It is important to be honest and tell the society the dangers of certain ideologies and display true uncensored footages of the terrorist act. We should not hide from reality nor bury our heads in the sand. Seeing the images/videos of the Wakeley stabbing was important to see the truth of terrorism that Australia is facing. We should not be censored.

Additionally, we watch movies on TV that are full of confronting images and brutal scenes. Much worse than the stabbing.
