**Circumstances Leading to Request:** Team Global Express flight TFX22 (Sydney to Melbourne) was delayed departing from Sydney Airport due to the Main Cargo Door becoming stuck following the completion of loading of cargo at 22:25. TFX22 is a dedicated freight flight and was loaded with a range of medical supplies, including cancer isotopes and other life-affecting, time-critical medical goods. There were no suitable alternatives for the carriage of these goods. A dispensation was granted for take-off no later than 23:45 local time. TFX22 had 2 crew on board. The aircraft departed at 23:35 local time.

**Circumstances Leading to Request:** Jetstar Airways flight JQ769 (Adelaide to Sydney) was delayed departing from Adelaide Airport due to a passenger suffering a medical emergency just before doors were closed, requiring the passenger's bags to be offloaded with them. During the offloading, the aircraft was damaged and engineers were called to access and fix the damage. A dispensation was granted for landing no later than 23:59 local time. JQ769 had 125 passengers including 3 children, 2 infants, 1 wheelchair passenger and 7 crew on-board. The aircraft arrived at 23:11 local time.
