The District Council of Loxton Waikerie submission to the Australian Government Department of Communications Mobile Coverage Programme

The District Council of Loxton Waikerie welcomes the Federal Governments review of its planned provision of mobile coverage and the proposed investment in the mobile network expansion and mobile black spot coverage.

The District Council of Loxton Waikerie is located on the River Murray in eastern South Australia and is part of the Riverland region servicing approximately 35,000 people.

The Riverland also attracts in excess of 1.0 million visitor's nights per annum, 416,000 day trippers and covers the intersection of major freight and passenger transport routes.

Whilst the major towns receive reasonable mobile phone coverage, areas particularly in a band to the south of Loxton and Waikerie ranging from Blanchetown in the west to the Victorian border to the east and from Waikerie west to Blanchetown receive no or very sporadic service.

This area generally consists of dry land and approximately 1000 cereal and vegetable business and produces an estimated \$250 million at farm gate.

With the price of grain fluctuating as regularly as it does, the modern farming business is put at a distinct disadvantage if through lack of mobile coverage the business is unable to respond accordingly to take advantage of peaks in price.

With farming enterprises now so highly geared and capital intensive in order to be productive in today's competitive global market reliable mobile coverage is an essential element of daily business.
