## **RE: Mobile Coverage Programme Submission**

Regional Development Australia - Ipswich and West Moreton ("RDA-I&WM") would like to commend the Federal Government on the development of the Mobile Coverage Programme. Enhanced coverage, competition and capacity of the current mobile networks within the RDA-I&WM region is an essential requirement to achieve the regions digital vision of Ipswich and West Moreton as a connected and productive region.

Ubiquitous mobile connectivity is driving change to the way we work, the way we communicate with customers and the way we solve old problems faster than any other technology ever – it will lead to more efficient business models and improved lifestyles for individuals and society.

As wireless capabilities become increasingly integrated within computer chips, the benefits of the computing world – innovation, short development cycles and low cost – are extending into mobile communications. As a result, traditionally unconnected devices are becoming connected – varying from smartphones, to cars and industrial machinery to farmland equipment. Increasingly the geo-spatial data that can be associated with a mobile device will drive changing business models in many sectors.

Ubiquitous mobile connectivity is becoming increasingly important in tourism, hospitality, agribusiness and education.

The Ipswich and West Moreton region is aiming to understand this global mobility trend and build appropriate infrastructures and applications to support and augment mobility to achieve optimal benefits over the next decade.

In relation to the Discussion Paper, RDA-I&WM would like to make the following comments:

- For all areas where Programme funds are being utilised for new base stations, except for extremely remote areas, 4G LTE and 3G mobile voice and broadband as a minimum quality standard should be applied;
- RDA-I&WM support the objective of mandatory local input to the 'list' of base station locations. The Commonwealth should provide an open mechanism to capture input to this list before the Programme is opened for application submissions;



- RDA-I&WM believe any utilisation of Public Funds should drive increased competition
  as well as coverage outcomes. Success should not be measured solely by 'new'
  square kilometre voice signal coverage increase but also take into account the
  exploding rate of data usage requirements. In essence the delivery of both data and
  voice is essential;
- RDA-I&WM believe that the definition of 'black spots' should also include areas where there is low signal strength coverage but also a low level of user experience relating to data transmission performance resulting in near unusable data:
- RDA-I&WM support the use of all applicable NBN Co fixed wireless, satellite, fibre and transit network infrastructure as an absolutely essential element to achieve optimal programme success;
- RDA-I&WM suggest that provisions for local community input, competition outcomes and network capacity improvement are included in the Programme assessment criteria; and
- RDA-I&WM support both Option 2 and 3 as the preferred delivery mechanism with either option to be applied based on specific outcomes to achieve increased coverage, competition and choice.
