Mobile Coverage Programme Discussion Paper Submission

On behalf of the members of the Warrenmang Fire Brigade I would like to emphasise the importance of decent Mobile phone and data coverage when it comes to community safety and implementing fire fighting strategies.

It is essential that life-saving information be able to be received and sent instantly from the fire front. Sometimes the CFA radio traffic becomes too congested and we actually need to use mobile phones to communicate with headquarters and other brigades.

The recent lightning strikes and subsequent two large fires which threatened the Moonambel area highlighted the need for mobile coverage. Even the families of the local volunteers could not ring their loved ones to find out if they were ok and the volunteers could not let others know that they were in direct danger.

People are more and more relying on the CFA Fire Ready App on their mobiles and of course would not receive the life-saving warnings and advice when living or staying in the Moonambel area. This area is frequented by many tourists who are not aware of the complete lack of Mobile coverage and often complain to the local business owners that their mobiles will not get any service to even get a text message or fire app notification.

As you would be aware Moonambel and Warrenmang areas are one of the worst affected areas for poor mobile coverage. This is even pointed out when you go to purchase a new mobile phone and tell them you are from Moonambel. The people of Moonambel and Warrenmang also have no access to broadband internet and have to rely on mobile internet which drops in and out.

We would dearly love to see some action taken to address this terrible coverage area as soon as possible as more and more people are relying on the internet and mobile coverage.
