The vote by the Liberal Party Council to privatise the ABC is a challenge to the freedom of the Press and therefore to democracy. In summary, the privatisation of the ABC would lead to greater conformity and less variety in all aspects of broadcasting through radio and television. 



The ABC must never be privatized. It was set up in the 1930's with an independent social and educational charter to support a robust democracy without political, corporate or commercial influence. It has done this for >80 years although it's funding has been cut by >40%. It has been shown to generate as much to the economy as its \$1 billion cost to taxpayers (< 10 cents per day). The

ABC'S continued even-handed broadcasting of true news and essential in-depth reporting of crucial issues (such as 4 Corners on banking malpractice, which brought on the banking Royal Commission) is essential to a robust democracy. It is also essential to counter biased, untruthful reporting and downright propaganda disseminated by the increasingly powerful Murdoch controlled News Corp. media monopoly. The egregious regular climate change denying columns by Andrew Bolt and Graham Lloyd and the absence of any real scientific climate change reporting in the face of the 98% consensus on the reality of global warming are cases in point. This issue and others such as corruption in banking and coal power generation and pollution by LNG giants who pay little or no tax and nothing for their pollution are issues crucial to the world and Australia and that are continually misreported by the Murdoch media. ABC is the only media organisation that counters these lies.

I have lived for 10 months in the US, a nation with > 350 million people which has no national broadcaster. It is like living in the dark. Commercial radio and TV is pure propaganda trash not worth listening to. The only significant non-commercial broadcaster, NBC holds regular fundraising drives urging listeners to donate so they can continue broadcasting. I am a passionate believer in the value of the ABC to provide me and my family with independent news and programs that have not been influenced by sectional and economic interests. The ABC has become as a punching bag for narrow political, commercial and ideological interests, such as the Murdoch Press. The best way for me to articulate how I feel is to quote from Dennis Muller from a recent article by in relation to a motion to privatise the ABC:

"One of the proponents of the motion was Mitchell Collier, the federal vice-president of the Young Liberals. He said there was no economic case to keep the broadcaster in public hands.

No economic case. Where the ABC is concerned, that is a false premise on which to proceed. The ABC was explicitly not established for economic purposes or in pursuit of an economic ideology. It was established for social, educational and cultural purposes.

It was also established on an explicitly non-commercial basis: it takes no advertising. Why? Because it was believed advertising would weaken its independence. The policymakers of the 1930s had seen only too clearly how beholden the newspaper proprietors of the day had become to commercial imperatives: the demands of advertisers and the pressure to increase circulation, even at the cost of editorial quality and integrity.

The newspapers of the day had also become mouthpieces for sectional interests. In Melbourne, The Argus stood for the interests of the mercantile classes and conservative political causes; The Age for a kind of Protestant liberalism and social justice. It supported the miners at Eureka.

The bipartisan political vision for the ABC was that it should not be vulnerable to sectional interests or commercial pressures, but should exist to serve the public interest in the widest sense.

Nonetheless, in a political age dominated by the narrow perspectives of neoclassical economics, it is self-evidently no longer enough to rely on ideals of the kind promoted by Menzies and reflected in the charter.

In her reply to the privatisation motion, the ABC's managing director, Michelle Guthrie, told the Melbourne Press Club the ABC contributed more than \$1 billion last financial year to the Australian economy, on a par with the public investment in the organisation.

She also advanced an efficiency argument, saying the ABC's per capita funding had halved in real terms over the past 30 years, and warned that the latest cuts in funding – \$83.7 million in a so-called efficiency dividend – would serve only to punish audiences"


We live in a world filled with false news and fuelled by various self-seeking agendas; and so we live in a world in which the ABC is more important than ever.


Since the mid 1950's I have been a consumer of the services provided by the ABC. Most of this in the early days were things like cricket on the TV and radio, plus other sports where our family always depended on the ABC for good and passionate commentary.

For longer that I care to remember I have been a constant viewer of and listener to the ABC and over recent years as the ABC has moved into the digital age I regularly use products like iView, ABC online etc. As a city resident I have plenty of choice for viewing and listening but always choose the ABC for full and complete news, detailed unbiased analysis and commercial free entertainment. I do not need to depend on the ABC for emergency broadcasts. I can only imagine the comfort that must come for rural and regional consumers of the ABC services to know that they have a government funded and reliable source for their news, current affairs, entrainment and, more importantly, for their emergency service information. No private organisation could ever provide such a valuable service.

Some years ago the ABC was forced to close down their radio Australia service which provided the voice of Australia throughout this region. We now see other countries providing TV and radio services regionally and globally while Australia is mute due to government cuts and lack of insight into the value such services provide to the host country.

Much of the focus on the ABC recently has been the cost to the taxpayer for the ABC and can a government in 2018 continue to finance such an expensive operation. These has also been much debate about the ABC perceived bias. This Senate inquiry is considering if the public broadcasters have an "advantage" over commercial organisations. We should remember that the 'commercial organisations' that may feel they are disadvantaged are, in the main, large multi-national corporations with vast networks, massive profits and great influence in the political sphere. To suggest the ABC may have some advantage is has no basis in fact. If this inquiry and the ongoing attacks on the ABC are based only on the financial cost of the public broadcaster the using this logic, can taxpayers also fund, for example, the Canberra War Memorial as well as its very expensive current renovation program, and all the overseas memorials to war dead (e.g. like in France, Belgium) – these places provide no economic benefit to Australia and are in fact a huge cost. The people they remember are dead so can derive no benefit. Should we also close or privatise all government owned galleries and sell of the expensive art works. Further, there is no economic case for the public to financially support people in poverty or provide public housing or to maintain public parks and gardens for example.

Clearly we would never abandon our remembering of our war dead, no matter what the cost. So why do we allow the attack on the ABC which many of us hold in the same regard as symbol of our cultural uniqueness and a pillar of our democracy and commitment to free expression. The different viewpoints debated openly on ABC are essential for a well-functioning society, and we would never see that on a privatised ABC or an ABC bound by the government of the day ideology. We cannot allow this inquiry to degrade into just opening the doors for further attacks on the ABC by factions within the government or business which may be offended by the scrutiny.



My children watch almost exclusively ABC programming, and my 3 year old daughter's impromptu singing of 'ABC kids I-view app' to the tune of the alphabet song would warm the cockles of some ABC marketing guru's heart. My kids have been raised on Playschool, Sesame Street, Peppa pig, Ben and Holly's little kingdom, Sarah and Duck, Puffin Rock, In the Night Garden, Numtums, Wallykazam, Andy's Prehistoric Adventures, Octonauts (which have such excellent marine biology information as to be astounding), Horrible Histories, and many more. I still love the shows I have grown up with on the ABC, and my DVD collection owes a lot to the ABC shop. The traditional relationship between the ABC and BBC has been a tie between Australian culture and it's British origins, allowing us to engage with new and old cultural touchstones. The ABC is not beholden to political or commercial interests, which allows it to serve its employers- the Australian public- with all the integrity which I have come to expect and appreciate of Australian public servants in general, and the fine examples at the ABC in particular.


A strong and independent public broadcaster is an integral pillar of a democratic society. It allows for a discourse which is not beholden to corporate or political interests, but instead is beholden to the public whom it is created to serve. It belongs to us. It serves us. It does it well, and we love it for that. The bond between the Australian public and the ABC is a relationship built on trust over decades of dedicated service and demonstrated integrity. This reputation ought not to be attempted to be sullied for reasons of political expediency. The ABC is not beholden to any government of the day, to no political party, and anyone who does not like what they say when they report the facts should see that they change their behaviour and thus the facts, rather than seek to silence the reporting and discussion of those facts. It is unscrupulous to say the least to seek to undermine the ability of the ABC to report factual information regarding the behaviour of political figures in their roles as politicians. [The Australian public have every right to know the facts regarding those who are, in essence, their employees as well as their representatives. If our representatives do not wish to experience oversight then they should perhaps consider an alternative career choice.] If there is an incorrect statement by the ABC there are mechanisms for redress, which politicians seem to be so adept at using they have begun to use them frivolously as an apparent attempt to intimidate or influence the ABC. This ought not to be done. There is no place for political interference in a public broadcaster- a broadcaster who only reports the government's preferred perspective is a 'State broadcaster' rather than a 'National broadcaster', and is usually found in a corrupt or totalitarian regime rather than a vibrant democracy. If we seek, as we should, to maintain a vibrant democracy, then our public broadcaster ought to be bolstered, well funded, and allowed to act with the public interest as its primary consideration.

Commercial media outlets do not have the same requirements placed upon them, either in terms of legal obligation to provide high quality programming to fulfil a number of informational, cultural, educational and entertainment requirements, nor do they have the same moral obligation to the Australian public as the ABC, as the ABC are ultimately employed by the Australian people in a way that commercial media outlets are not. The very idea that being legislatively created and publicly funded gives a public broadcaster an advantage over commercial outlets misses the role of the legislative obligations of the ABC as distinct from commercial outlets which do not have these obligations. The ABC has an obligation to provide high quality educational programming which supports the education systems provided by the states. The free provision of these programs by a government entity ensures that the focus of that provision is on meeting the education and curriculum needs of the Australian public, rather than skewing focus due to commercial or ideological reasons. The free provision of these programs makes it possible for all to access this content, providing both equality of access across all forms of schooling and informal learning, as well as providing value for money for the Australian public due to economies of scale and removal of profit as a consideration (as individual schools are not then requiring increased funding associated with increased cost of individual sourcing of analogous educational materials). In the case of 'The Handmaid's Tale', a television adaptation of a text which I myself studied for English Literature in year 12, the interests of formal education combine with both informal education and entertainment. This adaptation could be used to support the study of the text in Literature for year 12, studied in its own right at university level, or used to spark a wider cultural engagement with the central themes explored in the text and which are currently more relevant than ever.

The ABC and SBS also have the obligation to provide high quality entertainment materials. This is another important way in which they serve the Australian public. This ensures high quality programs are available to all, and without providing access to your brain for advertising as a kind of 'fee for service'. Only the ABC is, in this regard, truly 'free to air', though of course we have already paid for the service through our taxes, which is why we should not have to pay for it again by watching advertisements. The requirement of the ABC and SBS to provide high quality programming of all kinds sets the standard for television in Australia, and as such elevates what is offered commercially. Commercial interests, contrary to their own opinion, are benefited by a strong public broadcaster as they are seeking to provide something as high quality as the public broadcaster's offerings, thus providing a higher quality service.

The ABC and SBS also fund Australian made content, providing much needed support for Australian artists and industries. Broadcasting Australian content not only provides Australian jobs and supports Australian creative industries, but develops and demonstrates Australian culture, which is essential in a global media environment which has a tendency towards homogeneity. Australian cultural distinctness and diversity is both mirrored and fostered by receiving representation on broadcast media.

The ABC and SBS are beloved of the Australian public for good reason. The ABC is more trusted than Australian politicians, and as such Australian politicians should consider whether they are in fact as deserving of that trust as the ABC, rather than attempting to undermine Australia's trust in the ABC. The ABC and SBS should be treated with respect, as they have treated us, the Australian people, with respect. If you treat the Australian public with respect, and seek to serve all Australians equally, then you will be in good company with the SBS and the ABC.


