




Finally ABC radio is very important, especially in refusal/regional areas. It has local content and keeps communities together.

All of things are hugely important areas of tv/radio. Yet most of these would not be supported by commercial networks. As we have seen by the lack of telecommunications in rural areas once phone networks were privatised, rural areas are not high priority for advertisers who pay for the commercial networks' dollars. Nor are good quality children's programs, Australian drama or hard hitting journalism.

We have 3 commercial stations already, so there would be plenty of space for such shows if they wanted to do them. The fact that they're not shows that if the ABC were privatised, all of these shows would disappear from the cookie-cutter new channel too.

Some people claim that the fact that advertisers won't pay for these kinds of shows shows that we don't need them. Yet many people, who aren't high priority for advertisers of retail goods, do watch them. And their impact on the nation also is a lot higher than the numbers suggest; producing changes in policy, keeping local rural communities together and giving our kids a great start in life. These important nationwide impacts are the kind of thing that a Federal Government should pay for.

In conclusion, I once again urge you most strongly to keep the ABC the great quality, vital public network that it has always been.





Our national broadcaster, the Australian Broadcasting Corporation (ABC), is world-class in its standard of journalism and trusted and relied upon by Australians for its thorough, fearless and unbiased reportage in a world increasingly filled with controlled media, unacceptable bias and fake or pointless news / entertainment. Australians trust and rely on the ABC to undertake groundbreaking investigative journalism and present comprehensive coverage, analysis and commentary on important issues (to name just a small handful): on the lack of probity and due process in relation to the financing and approval of the Adani mine, on the dying Murray-Darling, on the Banking Royal Commission, on the impact of AI on our society and workplace, on the rape consent law reforms in NSW, on foreign interference, on the Federal Budget and elections, on governmental, social and world events. It is a vital pillar of our press media which helps to maintain transparency and honesty in every aspect of our lives, our society and our systems and government.

People often say watching television dumbs down children. My various circles of friends, family, and colleagues, who have all been brought up with "Auntie", have always passionately argued against this view. We love the ABC because it does the reverse of dumbing down: it challenges, enlightens, and entertains, it broadens our minds and shows us what is out there and what is within. It has been, and continues to be, a rich education for any individual, child or adult, from any background.

When I was living and working abroad in London, I missed the shows and presenters of the ABC, even with the availability of the venerable BBC (and the annoying prevalence of the Murdoch press, like an annoying mosquito in the room). The ABC is something Australians love, trust and are proud of, as much as the New Yorker is loved and venerated. The ABC is part of our cultural heritage, a unique voice, and a worthy representation of our future. A government attempting to sabotage and take away this prized asset is the equivalent of a corporate board recklessly destroying value and brand - it is not something that is rewarded by stakeholders or the market.

Our household (and those of our friends) trust the ABC to keep us informed about the world, our current society, and the things which influence our collective futures. The ABC stands out strikingly in its quality of news coverage, originality and independence of thought and opinion, and exercise of intelligence in analysis (as opposed to prejudice or a party line), a stark contrast to the background noise of other commercial press offerings. It seems irrational to attack and try to get rid of something that continues to expand our horizons, whose loss would leave us with the drab, woefully inadequate, unreliable, and, frankly, boring alternatives of the Murdoch press.

There are so many examples of the quality ABC content we love: the series of articles on the AI Race and domestic violence in the church on ABC News Online, the annual Federal Budget coverage night, Ian Verrender's analyses of economics and finance, the 7.30 Report and Leigh Sales' interviews, the ground breaking Four Corners investigations, Media Watch, the discussions on The Drum, the stories on Catalyst and Compass and Australian Story, the thought-provoking debates on Q&A, the late and very much lamented Lateline, the Friday night and Sunday lineup of programmes, children's educational entertainment shows, and the list goes on.


In the television and broadcasting industry, there is a saying: "content is king". Despite cuts to its budget, the ABC is clearly and quite effortlesly ensconced upon the throne in this regard. Imagine the greatness that could be achieved if the government invested in the ABC instead of attacking it. (Imagine what the ABC

could achieve if it had the budget the Murdoch press plays with.) If any Australian media outlet were put forward to compete with the likes of Google and the other online giants in terms of original and quality content, the ABC would be the one well-placed to do so.

The mark of a free and robust society is the quality of its press - intelligent, responsive, fearless and rigorous, untethered to the leash of government / state or commercial masters. What does it say about our Australian society (and its politicians) when it aligns itself with countries like Russia in trying to get rid of independent, critical or dissenting voices?

In the corporate world, diversity is being championed within organisations as a programme for shaping the corporate cultures of the current and future generations, an instrument to foster a strong, resilient, competitive organisational ecosystem. Shows and ideas later popularised on commercial networks were grown at the ABC. Music outside of the mainstream of commercial pop has been find-able and listenable through the ABC. The move into digital platforms, like ABC i-view was way ahead of commercial networks. The organisation is hardly perfect, but the amount we have paid for the creation of content that focuses on our national character and psyche is a pittance. We need to own a record of our history and we, as a nation, need to represent our voices and lives with a myriad of different shows that have nothing to do with marketing and product placement.

No ABC means an easy run for authoritarian governments, but for us on the ground it means our cultural and political voice is silenced by our allegedly democratic leaders. Content becomes exclusively international and the local stuff gets no airing or hearing.



The ABC's charter says its functions are 'to provide ... innovative and comprehensive broadcasting services of a high standard ... and ... to provide broadcasting programs that contribute to a sense of national identity and inform and entertain, and reflect the cultural diversity of, the Australian community; and broadcasting programs of an educational nature.'

It was established on an explicitly non-commercial basis because it was believed advertising would weaken its independence.

I rely on the ABC new and current affairs for an independent view of what's happening in the world. I know I will get information and view-points I will never read in the privately owned press. The ABC's independence from advertising revenue allows it to air and discuss views that advertisers may not like or support. Independence from government interference is important for the same reason. Successive heavy cuts to its funding over the last 4 years are undermining the ABC's capacity to fully meet its charter. This appears to be a punishment for raising issues that have caused the government embarrassment. I think the public has a right to know what is happening and to hear the government's explanation for it.

The ABC produces and presents innovative new Australian documentaries, films, games shows, comedy and other programs that are ground-breaking and would never get backing elsewhere otherwise, even if they are picked up by commercial channels once proved successful.

I am making this submission because I am concerned by News I have read recently discussing the possibility of privatising the ABC.




