And of course, the ABC does news and Current affairs broadcasting better than anyone else. Who else will do a program like Q & A? Who else will do 'The Checkout' or 'Gruen'?

If the commercial stations are complaining about the ABC, perhaps they should look first at what they are offering by way of programming and stop looking for scapegoats to explain their own failure to attract the audiences (and commercial revenue) they want.





Not only are their programs full of very old movies or American 50's citcoms, there is a virtual drought when it comes to analysis of the news or current topics. When a major horror story emerges, for instance, such as high school shootings in the US or extreme weather situations, these are constantly reported over and over throughout the day until this news is superseded by some other dramatic event. They are shown with all the highly emotional rantings without any sensible and often factual material, squeezing the maximum sensational response for the audience who apparently, like ghouls around a road accident, can't get enough of the gory details. This kind of journalism is relatively absent in the ABC.

It seems clear these right wing Liberals are concerned that honest reporting more often presented by the ABC is undermining their power base - and of course in the case of Mad as Hell, lampoons, with brilliant satire, those obviously 19th century thinkers who are just plain stupid, nasty or ridiculous. This program, which I have recorded and resort to in times of depression at the state of the world, restores my sanity with laughter.

If there is any move to privatize this Australian icon, the envy of the world, I and my wife will be out their demonstrating with all the other defenders and use every protest method we can to wake up Australians to what they have and what they stand to lose.


I grew up with the ABC. It was the only channel that provided real educational material.

We strongly protest against the privatisation of the ABC. While we now live in the national capital our families lived in the country. ABC provides rural news on local stations as well as state/territory and national news. Most commercial channels provide state/territory news and national news but not a great deal of local news. Commercial channels seem to have the idea that Australians are unintellingent and incapable of thinking so provide a steady diet of "reality" tv. Incidentally "reality" tv that is carefully crafted via a matrix of traits and characteristics chosen to "reflect" the population. ABC provides a wide range of programming content, some specifically Australian in content in drama and the arts. Commercial tv doesn't. ABC through radio and tv has in the past provided solid content on science and health matters through programs such as Catalyst on tv and Dr Norman Swan's radio program. It has greater diversity of presenters better representing our country's population. There is also a greater diversity of world news presented on ABC through programs such as Foreign correspondent, this is not seen very often on commercial channels. We note that the United Kingdom has not commercialised the BBC and Public Broadcasting is still available in USA. Contrary to the opinion of certain members of Parliament we find the ABC is less biased in its reporting than any commercial channel. It is essential in our media to maintain at least one voice that is not subject to the vagaries in opinion of whichever owner is in control at any given moment, something very evident in the reporting seen currently in print media and commercial tv and radio. In doing a simple analysis of tv programming this week commercial tv devoted 1 channel to horse racing, 1 channel to "lifestyle" programming, basically American lifestyle, 1 channel to UK tv, 1 channel to American comedy, and the list goes on. Some of the "reality" tv programming was demeaning to both the viewr and the participants and clearly carefully edited to create the "heroes and villains". Much has been removed from the independence of the ABC in recent years since the strident calls about the so called bias of the reporting. We maintain it is necessary for ABC to retain its independence from commercial interests to enable the indepth reporting on issues of the day that leafs to excellence in journalism such as Four Corners. Dear Chair, Officers and Appointees of the Inquiry,

I wish to make a submission to this Inquiry concerning the future of the ABC (Australian Broadcasting Corporation) and to a lesser extent SBS (Special Broadcasting Service) (which is hybrid-funded) – this in the context of the recent Liberal Party Motion (carried) that the ABC be privatised.

I am intensely and bitterly opposed to the privatisation of the ABC.

These are some (not all) of the reasons I oppose privatisation of the ABC:

The ABC Charter is a comprehensive document setting out a series of responsibilities including

"broadcasting programs that contribute to a sense of national identity and inform and entertain, and reflect the cultural diversity of, the Australian community;"

- A privatised ABC would have no obligation except to its shareholders, to provide profit.
- All sense of national cohesion or 'balance' would be lost.
- As it stands, the ABC is required to provide 'Balance' by contrast, 'Rupert Murdoch, Alan Jones, (insert name of mogul or shock-jock here)' would not.

As it operates currently, the ABC is at the forefront of investigative journalism in Australia. For-profit media organisations are not, in part because the moguls who own them are likely to be the target for an independent investigation into conflicts of interest.

The ABC as is exists to serve the entire nation;

A privatised ABC would serve its shareholders only.

The ABC as is informs the so-called 'national conversation'.

When a topic is raised by the ABC, the commercial broadcasters leap upon the work done by the ABC – witness the Moonlight State – profiting from work done by others.

One way to look at is this:

"There are effectively only two broadcasters in Australia – ABC/SBS and commercial – because all the commercial broadcasters are almost indistinguishable."

For example, no commercial broadcaster would produce anything as thought-provoking or aboriginal-centric as 'The Slap' or 'Mystery Road'. These are World-Class productions; the envy of countries like the US (which produced its own watered down 'The Slap') and the rest of the English-speaking world, lacking an interaction with a 60,000 year old culture.

In fact, the terms of your Inquiry are asking the wrong question:

It does not matter if the ABC and SBS are competitively neutral – because the functions of SBS and the charter of the ABC have so much less to do with selling soap and automobiles.

We need the ABC and SBS (to a lesser extent) as is.

At the moment we have one (bought and paid for) voice in the commercial sector, and one (required to be neutral or balanced) voice that is publicly funded. I'd pay more taxes to ensure that this remains the same.

Privatise the ABC and this will silence many voices that deserve to be heard; we will wind up with a less just, less equitable, less vibrant nation than the one that has evolved under the gentle and at times confronting information flow enabled under the current arrangements.

Hypothecated funding is one solution. Please examine that, if possible within your terms of reference – or note that it should be examined.

I do hope you have the courage and morality to see how damaging the ABC (and SBS) damages our nation for the future. I want my grandchildren to hear the reporting that comes from the ABC – and if the ABC is a thorn in the sides of ALL political parties – so be it!





I have grown up with the ABC. I have grown up with its child-centred programs, its drama programs, its news services, its radio.

I lived in a small town where the ABC was the only TV station; where the ABC was the only place on radio with good news coverage, or with alternative music choices. I grew up knowing there were two or more sides to every story, because the news programs my family watched were full of debate.

A few years ago I visited New Zealand. One of the things I noticed missing was an impartial New Zealand voice in the media. What was apparent was a media controlled by power groups with highly obvious agendas. New Zealand has no public broadcaster, and it shows.

I am aware that private media groups have been attempting to dismantle the ABC for many years, It is a publicly funded, not-for-profit media outlet with high production values and a mission to be impartial. It is, therefore, both a competitor for viewers, and a non-partisan observer and critic of society. It is an ideological thorn, as it were. No wonder the private media want rid of it – or better still for them, control of it.

The ABC services the whole country and its charter insists that impartiality be respected; that opposing sides in any argument or issue are given the chance to put their case. The few times this has seemed to be in question, the ABC have undergone massive public, external and internal reviews and investigations.

The privately owned media are not subject to any such overview.

The ABC are the only service to broadcast without commercial advertising. The capability to watch programs without being forced to watch a series of adverts begging me to buy stuff is bliss. Our world is full of the pressure to buy, buy buy. I resent being forced to undergo that pressure during my own leisure time.

As a result, the ABC is the only station I watch. It is the only station my children watch – they too dislike advertising, and they too have grown to appreciate considering more than one side of an argument.

Privatising the ABC would be a mistake driven by a flawed ideology and a scared and vengeful political party. We will never get it back. Media wise, it is a national treasure. 


