Government policy in privatising its public assets has backfired in many areas and the public broadcaster should not be risked. A small but pertinent case in my local town of Nelson Bay was the sale and privatising of a publicly funded marina. Sold in the late 80's for \$4.5M to d'albora Marinas, it was resold 5 years ago for \$20M to Ardent leisure who also own Dreamworld where 4 people died a few years ago. I know from running a commercial vessel from this marina that Ardent did no maintenance on this marina in all the time they owned it. The dock my 2 vessels are on is very old and only 2 metres wide, one of the dock fingers broke away recently due to corrosion of brackets with one of my vessels attached in a gale and it could have easily caused a fatality. At times it carries up to 700 passengers on it at a time in the summer. Despite countless warnings from staff and vessel operators that the dock requires extensive emergency maintenance the company only wanted to strip profit. It has now changed hands again for \$26M and I doubt there will be any maintenance until someone is hurt. This although perhaps a little obscure to the ABC privatisation plan highlights that there is no guarantees that private enterprise and "the Market" can be trusted to tell the truth or act to benefit the community. Now it might be justified financially by governments to sell material assets but the risk to our democratic system in flogging off our National broadcaster would to my mind be lunacy. 



I write in order to state how much I value the current status of our public broadcaster. I depend on its programmes for well-sourced information since this town, like many others, has only a single newspaper, and that with a very conservative, biassed and limited range of views. Any introduction of broadcast commercial advertisements must detract from the pleasure of following a programme in the form intended by its creators, but, much more importantly, must introduce the potent factor of 'self censorship', since the broadcaster would become dependent on income from the advertisers and so must try to avoid criticism relating to their product or to their known political affiliations.

The Public Broadcaster must be free to offer reasoned criticism of manufacturers, of other news sources, and of political events both national and international. Since any potential owner of a privatised ABC is likely to have political and international connections, or even outright overseas control, as in the case of the Murdoch press, privatisation must inevitably lead to restriction on analysis and informed criticism of policies and actions of governments.

One need only consider the aggressive expansion of State-controlled and very well-funded Chinese enterprise in this country to realise the possible result of making control of the public broadcaster available to the highest bidder.

In short, I cannot stress too strongly my opposition to the current calls for sale of the ABC and, at the same time to stress my concern at the low level of current funding of our broadcaster.


Subject: The ABC Is a balanced service and should stay public


The ABC has been a part of our family's viewing for so many years with trusted news programs such as "Four Corners", the "7.30pm report" and "Q&A" only to name a few.
