




Many regional areas, in particular, depend on the service provided by the ABC.

The Australian Government needs to acknowledge the importance of the National Broadcaster, and fund ir properly, not privatise it.





We live in a time when our society seems to be faced by the greatest schisms I've seen since the Vietnam war. I believe the ABC has become a focal point of that schism, because it puts integrity before political pressure to conform to ultra conservative views.

I don't feel that old, but I must be. These days you can channel surf endlessly, or just stream or download, and guess what I don't even own a television, but if I did I have no doubt it would be stuck on ABC, as I find the commercial channels shrill, cheap, full of faux indignation, and too many wearisome advertisements for stuff I don't want.

The thing I most admire about the ABC was the way it embraced the digital age. The way radio programs can be combined with text and images online, the way iView finally freed everyone from being obliged to stay home or else they'd miss an episode. I have also been impressed by ABC Local and ABC Open, absolutely sensational programs and activities right here in our community and all over Australia, an opportunity to learn and understand about our once great country, and the people we share it with.

There is absolutely NO WAY that you can convince me that if the ABC was privatised, there would be a service like ABC Open. Open has already suffered cuts, to my disappointment; I worked with a number of Open people professionally in our community, and I saw community activity, people learning and developing, ESPECIALLY in this digital age expanding their skills both for pleasure but also in ways that enhanced now-essential life skills.

DO NOT PRIVATISE OUR ABC. We see through this privatisation racket now. Here in Victoria the loss of our SEC was shameful. I have no doubt an SEC R&D section would have us far advanced in renewable technologies, to massive public benefit. I am disgusted by small minded and narrow viewed people who fail to see the importance of an independent public broadcaster. I pay my taxes precisely for public good. I am infuriated that my taxes might go on politicians court fees, useless inquiries into the NAIF, or on material for war.

Democratic societies require a strong media which is broad and diverse. Media needs to hold those in power to account and to expose the light on those dark corners.

Irrespective od an ideological position, no one group individual or entity holds a monopoly on truth and wisdom. A society needs the diversity of views.

Even if the ABC did lean left and I do not accept that's that a bad thing when others hold the right. The almost unanimity of the Murdoch press on some issues is offered a counter point by the ABC and Fairfax.

In terms of bias, I do not accept that it is as evident and prominent as the critics assert. Its shows offer differing perspectives. Q & A by way of example usually has a member of the Government represented and a member of the Opposition. The IPA has had representatives appear as have the Business Council and Australian Industry Group. Journalists from the News Ltd press are guests as are journalists from groups such as Get Up. Its panels are more diverse than the make up of the Australian Parliament. To illustrate its panellists comprise men and women of different sexual persuasions and gender diversity. There are corporate executives and Judith Sloan is a frequent guest. There are community activists and young people as well as old.

In debates of religion Cardinal George Pell appeared alongside debating Dr Richard Dawkins.

Shows such as Insiders have a broad cross section of journalists. Former Costello staffer and journalist Nikki Savva is a member. David Marr can often be seen sparring with Gerard Henderson who articulately puts the Conservative case.

Lets look at the commercial reality affecting private media groups. They are increasingly using media releases in place of real news. News rooms and the of journalists are shrinking. Privatisation or cuts to the ABC are not going to be immune from this phenomenon. It makes the ABC even more important and integral to our Australian democracy.

Private media by its nature is commercial. Its earns its revenues from advertising sales and sponsorship. Is it likely to hurt its commercial activities and imperil its profits by investigating frauds, environmental vandalism, safety concerns or culture within insurers. Any one who has ever watched morning TV will note the high number of ads for Funeral Insurance and Aged care facilities. Would a commercial broadcaster investigate corruption or unsafe practices in the age care sector as the ABC did?

Private media is pwned by corporations. Is a private entity such as The Australian, The Daily Telegraph or The Herald Sun going to expose corporate governance issues at its parent company. News as part of the Murdoch controlled interests are now a foreign media company. Are they going to allow an investigation into many of the taxation ports utilised by these companies to minimise tax.

This is where a strong and fearless broadcaster comes into its own.

Looking at the quality of programming. Commercial broadcasters bring us a plethora of reality television. We are bombarded with many hours of house makeovers, survivor programmes and cooking shows. Foreign television programmes are favoured by networks as they are cheaper.

Australian culture and values are preserved and protected by the ABC which has this as part of its charter.


The late Hector Crawford the doyen and considered by many as a father of australian Television fought hard for Australian content as have others in the industry, Minimum content regulations have ensured we have some Australian TV. The ABC has in line with charter obligations provided us with many fine examples. Past shows included Power Without Glory, Seven Little Australians, Patrol Boat and more recently Glitch, the Doctor Blake Mysteries and The Miss Fisher Murder Mysteries.

I will again look at the issue of Impartiality. Senator Hanson doesn't like the ABC as they examined her party and did an investigation. They did also however, do a programme on the dysfunction of the Australian Greens. Both the fringe parties-on the right and left were examined.

John Howard was able to produce his documentary on Menzies. Leadership tensions within the Liberal Party were examined in a series of programmes as were the Leadership ambitions on Hawke -Keating and Rudd Gillard.

The ABC is a fundamental part of our democracy and must be protected.

The coalition may feel that they are targeted at the moment but they are the party in Government. Whoever holds Government will of course get more scrutiny as they make the decisions and sit on the Treasury benches.

I grew up watching the abc. The first 10 years of my life I had the majority of my TV content being voiced by Australian people in my native accent. I was protected from harmful advertising such as sugary drinks and fatty foods as a matter of course. Our children need a safe place to learn and grow with Australian content that explores the depth and breadth of people who call Australia home. We need an non commercial space that is required to show and create new Australian content. Including having a dedicated kids channel.

Even though as an adult I've branches out and now watch a lot of American and British shows, the ABC is still my primary source for Australian made, Australian voiced content. It's content they are world renowned for like the Miss Fisher's Murder Mysteries. Much like the public BBC, the ABC is producing content which promotes some of the Australian best talent we have in all levels of radio and tv content production.

As a person living in rural Victoria I rely on ABC local radio to ensure I stay safe in the event of a natural disaster. Working in rural community health, visiting clients in their homes, ABC radio national keeps me safe throughout Fire season. I am seriously concerned that we would lose a central source of vital safety information if we privatised the AbC because while that information saves lives, it can't and shouldn't be sponsored by anyone. Ads have no place in safety messaging.


As a health worker who works closely with aged people in rural areas, the only radio stations they listen to are ABC channels. I know all the frequencies now because that's all anyone ever wants my help finding. It is their primary source of news, discussion and provides vital access to new ideas which can help reduce the likelihood of developing dementia. The abc radio stations also all provide vital information every hour: the time, date, day of the week. If you have memory loss and can't remember the day or date, this is vital to keeping you able to function at home. Many people use it to help them figure out when they should have breakfast, lunch and dinner. Routine and reassurance and repitician are essential to keeping people at living well at home as they age. If you wake up, think it's morning and put on your radio then you'll be reorientated within an hour and be able to go back to bed if it's acually still only 3am. Also, people with dementia are more susceptible to advertising and often have a reduced ability to differentiate between an optional product and one they must buy. Reducing their exposure to advertisements reduces the stress of having to discern what IS ADVERTISING and what is general programming. We have an aging population. Dementia is on the rise. Current national policy promotes people living at home as long as possible with increased services and supports. One of those vital supports is ABC radio.

The abc is my main source of local and national political content as it is the only station which broadcasts state and federal parliament live. Access to that footage and the corresponding radio broadcasts is fundamental to our democracy.

Privatising the ABC will reduce the amount of Australian content. It will impair access to vital safety information for rural people. It will remove the option for vulnerable old and young people to watch and listen to ad free content. It will reduce jobs for Australians who are involved in the huge breadth of current services which are based on community need not just financial gain.

Our community needs an independent, government funded broadcasting company. Dedicated to Australian news, current affairs, content and represents Australian people.

Don't short change rural Australians by privatising another service which just ends up reducing our access.
