I cannot imagine why this competes with any commercial media outlet. It is an essential piece of community infrastructure that is appropriately funded from the public purse.

Perhaps, more fundamentally, this inquiry has been established to answer to wrong question. Trusted public broadcasting - ie the ABC/SBS - is fundamental to our democracy. The ABC's charter spells out the ABC's requirement to be fair and unbiased in its reporting and this is constantly monitored. It is not a question of whether or not commercial media outlets are disadvantaged because of the public funding of the ABC and SBS. Rather, a free, ethical and respected public broadcaster is a fundamental tenet ensuring our citizens are well informed, governments and businesses are held to account, and hence our democracy is enhanced. Commercial broadcasters can and do represent the biases that emanate from their commercial masters and large advertisers. This too is part of the mix, but must be balanced by a completely independent and publicly funded public broadcaster.

My view is that the ABC is not the governments to sell. It belongs to all of us. Having paid my taxes for the past 40 years I would feel completely betrayed if it were sold. There is also a considerable amount of evidence against the sale of public assets. 

To my knowledge ABC Classic FM radio is still the only broadcaster of such a wide range of classical music both traditional and contemporary. Competitive Neutrality and the ABC

The ABC and SBS are institutions devised by a wise government to provide informed understanding of issues and events which the population can use to make decisions.

Changes in the orientation of Governments, political parties and the private owners of media occur constantly. How can we tell the fake news from real news? Australia's prosperity, identity and ability to integrate people from all ethnic backgrounds is entirely dependent on the rule of law. The rule of law is dependent on evidence based decision making. Where either of these processes breaks down, there is likely to be upheaval.

The ABC and SBS both operate news and information services which provide the who, what, when and where of events and provide some analysis based on prevailing evidence of the time, that is, the facts as agreed by most specialists in any give field. These facts or evidence may upset people who have an ideology to pursue. That is the role of any neutral institution whether publicly or privately funded.

Private media operators need to make a profit to ensure their continued operations and may choose not to cover issues or explore the depth of issues. Private media is subject to the editorial whims and ideologies of the owners. Private media is unable to offend sponsors, for fear of losing funding.

That is why ABC and SBS should be fearless institutions and honest brokers of evidence and issues and solutions. Governments should be mature enough to understand that criticism is part of the process of politics. Kill it and we will have a dictatorship. There must be a more accessible interrogator of the law than the court system. For most of us that is the ABC and SBS. Additionally they provide experimental forms of entertainment reflecting and defining Australian culture.

Private media have a different end result to the public broadcaster. Private media is beholden to both the owner of the medium and the sponsors who pay for the operation of the medium. That is, private media is constrained to provide content that is acceptable to sponsors and owners. Private media is also free to conduct witch hunts and to ignore serious stories of corruption which might offend a sponsor. The end result for private media is that it is the captive of its owners and funders.

The different outcome required for ABC and SBS to inform the widest cross section possible of all Australians from bush to city skyscrapers. This costs money and the commitment of government to provide neutrality.

Media in transition:

The current price pressures on so many existing main media mast heads means that change is rapidly destroying much of its capability. The different platforms by which people receive news puts a huge impost on any organisation to reach so many people in so many different locations, whose media consumption is from so many platforms and sources. For instance, people who don't watch 'The News' but will watch a political satire.

Competitive Neutrality

I believe that the ABC and SBS are competitively neutral. They are funded to a certain level by public funding. They provide jobs, pay fees, and provide news and a wide range of entertainment.

Up until recently, media moguls had deep pockets and could outbid the ABC and SBS on any desirable sport or entertainment product. The ABC and SBS have a solid following but do not reach 'blockbuster' status on many programs. That is, they are little threat to the ratings of network TV. Further, I do not like the current crop of commercial TV productions. I simply cannot stand the adversarial reality TV shows which is all they currently produce. Clearly, the number of people moving to streaming rather than commercial media to avoid Ads which pay for the programs and so create a financial spiral into bankruptcy. That commercial media is in disarray due to changing world financial realities and shifts in technology is no excuse whatsoever to destroy a still functional and relevant model of news, analysis, information and entertainment delivery that meets its charter for independent, evidence based analysis and culturally relevant programming.

That the critics of ABC and SBS are operating platforms which are not attracting even the small audience the public broadcaster commands is a problem of their programming. People do not want to hear/see/consume their content nor do sponsors want to fund their content. They cannot then look at the public broadcaster and call 'foul'. Keep ABS and SBS true to their original purpose of informing on evidence based analysis and enhancing our common culture, albeit with some pockets across all regions, ethnicities, socio economic enclaves and age groupings. Unless we have a common voice reaching all the diverse groups of Australia, we will have difficulty binding the citizens of our nation with a common understanding of issues which require solutions.

That explains why ABC and SBS have the need for their various platforms in radio, internet, bandwith for TV stations, etc. Private enterprise would abandon some regionals or some groupings. The ABC and SBS have a charter to reach as many Australians as possible and that requires funding.

I cannot imagine commercial media would be happy to have the ABC and SBS fully funded by advertising revenue. I understand there is not enough revenue to support the existing free to air TV and newspapers. Which domino will fall next, and, would privatising the ABC and SBS deliver anything to the public good? A privatised ABC and SBS could become rabid lefties to balance the rabid righties or the poles may reverse over time. Is it not in the national interest to maintain a strong, independent ABC and SBS whose charter included information and analysis based on evidence? Surely, a neutral editorial charter is better than an ideological one?


I have had subscription TV since 1996. The cost cutting and decimation of programming over the last 20 years makes it a waste of my money. The Skynews service used to work at neutrality but has become the captive now of the ultra right wing which does not exercise its editorial discretion to measure commentary against accepted evidence. It's about entertainment not news. If this is the model, then it is deeply, deeply flawed.

Clearly, public funding of the ABC and SBS may appear to be an unnatural advantage over private media but it is a worthwhile long term investment by government. It requires a robust, adult government to fund a media platform with a charter of independence. ABC and SBS deliver news, culture, drama, children's shows, documentaries, some local some imported, and news analysis measured against evidence. Perhaps at a time of flux in the commercial media, preserving the ABC and SBS news with strong independent charter will best meet the needs of Australia.

I urge the committee to also consider the cost benefit of the public broadcaster when considering the competitive neutrality of private media organisations with a different editorial imperative.

We love our ABC and SBS. We love the programs, the news, the analysis, the many platforms and stations operated by the public broadcaster because it delivers to Australians in a creative and responsible way. If it also makes governments uncomfortable, so be it.

If anything, the public broadcaster should be strengthened with more funding.

Sadly not all programs are excellent; repeat series, poor quality imports and game shows act as fillers because of the brutal cuts to funding over the years.

I admire the professionalism of the ABC crew who have nobly soldiered on providing the highest quality services to the community without fear or favour, despite the ongoing cuts, loss of staff and onslaughts of criticism. Would that our politicians could behave in such an exemplary manner in the face of attacks and insults by those who oppose them. If our politicians could carry themselves with the dignity of ABC presenters the public would respect and trust them more.

The ABC is an institution that all Australians can look up to and trust. It is inclusive, informative and highly educational. It seeks to represent all views and maintain high ethical standards. No commercial broadcaster could provide this level of dedication. Although I have managed to be quite well educated, circumstances have left me with a very modest income in my retirement. 

A commercialised version would be forced to cut costs, and access to remote areas would likely be first to go as it is expensive and the "market" is small. As it is, the ABC can continue to give service to everyone simply because it is publicly funded.

The privatisation craze has been given a trial and found wanting: the electrical power supply grid, the Commonwealth Bank, and Telstra all have grave problems since they left public ownership because they are not suitable enterprises to apply free market principles to. Public funds exist to be spent in the interests of taxpayers and to maintain equity across the country - it was only the neo-liberal model that pushed for privatisation regardless of the consequences. Anything that made money had to be transferred to the private sector as an article of faith.

In the case of the ABC, a critical aspect of a working democracy is a source of information that is reliable, accountable, and not pushing the interests of remote proprietors. The "undue advantage" argument comes directly from Rupert Murdoch, and his interests are not those of the majority of Australians. Finally, the increasing detachment of politics from reality makes the ABC an irritant to those in power, who see it as a check on their power because it is able to express inconvenient truths about the major parties, particularly those on the Right. To me it's clear they want to see it hobbled by putting it in the hands of people like Murdoch. Commercialising the ABC would change Australia for the worse.

It sometimes works for industries and delivers efficiencies and consumer benefits but sometimes it does not and there can be strong economic cases made either way. Ultimately however I do believe, like many Australians, that not everything that can be counted matters and not everything that matters can be counted. The value of a robust public broadcaster goes beyond economic efficiencies or political expendiency, it's about ensuring that access to information to better inform the public is not dependent on where someone lives or how much they earn. 



I have not heard one good reason why, after the nation's long investment in such a trusted institution and the long term evidence of continued trust by the public, one would even consider privatisation. To what purpose? In whose interests?

Personally speaking, the ABC has been my preferred choice of channel since arriving in Australia in 1975; and, as a media academic, I have many to compare it with. I have always read, listened to, and watched a wide variety of national and international media, as part of my job.

The ABC is considered - by everyone I know - as the 'go to' media source for all global breaking news, for sustained and informed expert coverage of events, and for a variety of thoughtful analyses of public affairs.

It is not a perfect organisation but ABC expertise and talent are exceptional. No other media organisation in Australia has the range of staff, or the global cultural capital of the ABC.

For over a decade, as an academic supervisor of hundreds of industry placements at a research-focussed university, I could compare the ABC's professionalism and educational commitment with scores of other media organisations and workplaces: in the state in which I worked, interstate, and overseas. The ABC was the highest-ranked organisation on the top students' internship lists.

The ABC is an outstanding leader in providing educational programmes, in entertaining, in covering public affairs, in providing appropriate content for its various audiences. It encourages those same commitments in aspiring graduates by helping prepare them for employment, giving them practical experience and guidance. That pro-bono work comes easily to a public broadcaster's staff, not so easily to many commercial media organisations.

The formal and informal training opportunities offered to high school and tertiary students by the ABC are carefully crafted. The standards expected of ABC staff, and of the interns they mentored are impressive.

Regrettably, the ABC, one of the most trusted institutions in Australian life, if not the most trusted, has suffered at the hands of governments reacting badly to democratic scrutiny and engaged criticism.


Although news cycles have accelerated, and politics has grown toxic, the current state of Australian political culture can't be blamed on the ABC! ABC reporters have initiated significant investigations into corruption and criminality and, at their best, have 'spoken truth to power' in a way which has seen justice done in Australia.

Privatisation threatens the robust and necessarily critical nature of a national broadcaster. Inevitably, journalistic standards are eroded.

Privatisation of the ABC would vandalise a widely respected cultural institution, and result in the

destruction of a public good and national asset.



When I first came to Australia almost 40 years ago I came from a country with a strong history of public broadcasting in the public interest. Its programs covered culture, political activities and events, local communities and major policy areas such as health, education, industry and agriculture as well as the European market, as it was then, and World issues. When I came to Australia I looked for the same informative programs, measured views and quality production. I thought to try the commercial stations so I could make comparisons. I found then and have found increasingly ever since that on most of the commercial stations there is effectively no news, certainly no or very little news of the state of the world outside this country or even local cities. Commercial news almost invariably follows the format of road accidents, crime, welfare fraud first and then if lucky a little national and political information. I watch with growing dismay how uncritical and unanalytical the offerings are. I can't imagine how anyone learns anything of value from this. Worse, its low quality I find is turning young people off the news altogether. Much the same can be said about coverage of current affairs, culture relevant to this country or its multicultural citizens or discussion of major areas such as health and education.

It is for these reasons that we must keep the ABC in public hands. It is impossible to imagine where our understanding of or even information about crucial national and international issues would be without Four Corners, Media Watch and the 7.30 report. Where would we be without high quality drama series such as the current Mystery Road. And I am just talking about television

I would like to emphasise too that ABC Radio, especially Radio National, is a truly excellent media resource. I listen a great deal, both at home in the morning and on the road several times a day. I hear a variety of excellent programs, from political discussion and reporting of so many areas never covered by the commercial stations from political issues, technology developments, science and music to religion to sport and entertainment.

I am also a family person. My French-born children have both married Europeans but decided to live in this country. My grandchildren have been brought up on ABC Kids, programs of marvellous interest and quality that both children and adults happily watch and discuss.

The ABC has a national charter and it can only fulfil those important obligations if it remains in public hand, with guaranteed levels of public funding to enable the high quality programs, documentaries, drama that are valued by so many. The ABC helps immigrants to get a proper feel for what is Australian, what is important and not sensationalised about events in this country and what it means to be part of a multicultural society in the fast changing Asian region of the world. It has always seemed to me that compulsory voting can only have full import and impact if voters have a good understanding of the issues we all face. Keeping the ABC in public hands is a major element of protecting and nurturing our functioning democracy, showing that populism is no solution and has the kind of ugly face that diminishes us all. Privatising the ABC would harm this country in multiple ways and bring no good at all in return. It is bad enough that the ABC has had to shed high programs and the staff who sustain them through endless cuts to budget and political interference in Board membership and functioning among other barriers to sustained excellence as an icon of what it means to be Australian. I urge you on the inquiry to recognise the enormous social value of our public broadcaster, the only news medium we all think of as 'ours' in a very positive and trusting way and advocate for its continued existence as a publicly funded central Australian institution, much lauded outside as well as inside this country.
