I've had a quick look through the RIS and clearly favour Option 3 for a number of reasons.

- 1. While the costs of installing at the subdivision development stage is considerably less than retro fitting it is an extra cost on developing the land at a time when economic recovery post COVID is important. Construction activity is clearly identified as a significant factor in this recovery.
- 2. While I'm conscious that Tasmania is yet to legislate for this, we have indicated a positive approach and will deliver
- 3. Legislative options at the Commonwealth level will require consideration of the differences on the ground in different States and Territories in any event
- 4. Including non-incorporated companies will 'sweep up' all sorts of small and minor subdivisions in areas which may not be serviced and require 'opting out'.

As the provision of pit and pipe is clearly a benefit to the purchaser, there may be better outcomes if developers are encouraged to include this and use it as a selling point.

The options are set out in the attached regulation impact statement (RIS) and a possible draft bill is provided.
